Delivering Economic Results

We believe in going the extra mile to do things right. Whether it's offering innovative responsible gambling programs or cultivating partnerships through our Support4Communities, we take great pride in our job. Along with our operators, Atlantic Lottery and Casino Nova Scotia, we reach almost every community in the province with entertainment for adult Nova Scotians and our visitors. You could say we fundraise on a large scale - 100% of profits from gaming go directly to help fund important programs and services. In 2013-14, the Payment to Province was \$123.3 million. This is equivalent to building nine schools, twinning 41 kms of 100-series highway or paving 379 kms of secondary highway.

Economic Impact of the Gaming Industry

1,091 ticket lottery retailers and 322 video lottery retailers earned \$34.3 million in commissions.

\$21 million in wages and benefits earned by approximately 538 employees who are directly employed in Nova Scotia's gaming industry.

Progressive

 Launched the Support4Culture program to raise important funds for arts, culture and heritage in the province. Profits from Support4Culture are reinvested to help grow the creative economy with an annual contribution of two million dollars. Introduced a new way for players to validate tickets at retail in partnership with Atlantic Lottery. In addition to the self-ticket checkers located at all retail locations, players can now ask their retailer to use the scanner to validate the ticket, while they hold on to it. To complete the validation process all the player needs to do is ask the retailer to "Wand it!"
